IMPLEMENTING UNIVERSITIES

- **Four Universities have volunteered to implement the project:**

- **Following two Universities have already obtained the permission from the competent statutory bodies of their respective universities and have implemented the project (partially) from the academic year 2019 – 2020:**

➤ **Savitribai Phule Pune University offers one year post – graduate degrees in Law (LL. M.) in five specializations viz.,**

- **LL.M. in Constitutional and Administrative Law**
- **LL.M. in Criminal Law**
- **LL.M. in Science and Technology Law**
- **LL.M. in International Law**
- **LL.M. in Corporate Law**

The University has started implementing the project from the academic year 2019 – 2020 in the all the five programmes.

- **Jagran Lakecity University has started implementing the project from the academic year 2019 - 2020 in their flagship undergraduate programme:**
 - **B.A. – LL. B. (Five Years Integrated Hon's Course)**

DESIGN OF THE DEGREE PROGRAMMES

- **Prof. Yogendra Srivastav from (JLC) and Dr. Sonia B. Nagarale (SPPU) have had drafts of their degree programmes (Step 1 to step 10) ready and they presented the same on December 3, 2019 for the perusal of the members of SAG – Law.**
- **After careful consideration, their drafts were appreciated and certain suggestions were made to further revise and improvise them as per the new format that was circulated and inputs provided.**
